# K-3 LITERACY MEASURE

# K-3 Literacy Measure

- ▶ Measures whether a school district or building is making progress in improving literacy in grades K–3
- ▶ Goal to show progress so 3rd graders are at a proficient reading level (400 or above) on either the fall or spring administration

# K-3 Literacy Measure, cont.

- ▶ Calculations rely on “Where Kids Count” rules
  - ▶ Student enrolled full academic year
- ▶ Students required to be diagnosed in reading by September 30th
- ▶ Students identified as “not on track” are to be placed on a Reading Improvement and Monitoring Plan (RIMP) within 60 days

# K-3 Literacy Measure, cont.

- ▶ Students identified as “on track” can also be placed on a RIMP
- ▶ Measure identifies students who were never on, or were removed from, a RIMP but do not achieve proficiency (400) on the OAA by the spring of 3rd grade
  - ▶ Will cause a demotion in improvement percentage
  - ▶ Decreases the overall numerator by one student

# K-3 Literacy Measure, cont.

Districts get credit for...

- Students not on track on the KG diagnostic, but improved to on track on the 1st grade diagnostic
- Students not on track on the 1st grade diagnostic, but improved to on track on the 2nd grade diagnostic
- Students not on track on the 2nd grade diagnostic, but improved to on track on the 3rd grade diagnostic
- 3rd grade students not on track on the fall diagnostic but proficient (400) or better on the 3rd grade OAA on either the Oct or May administration



# K-3 Literacy Measure, cont.

Though the improvement for each grade is calculated separately, a single improvement percentage will be assigned as the K-3 literacy grade for each district

- ▶ These grades are based on a state-wide average
- ▶ Misreporting your data impacts the grades for all districts

# Retention

- ▶ Retention element must be reported for all students not withdrawn by the district in FY14N
- ▶ The Student Retention Collection includes only the retention element (FN070) on the FN record

# Retention, cont.

The retention element is *only* collected during the Retention Collection

- ▶ The Retention Collection is the only opportunity for districts to submit this data
- ▶ Students new to the district for FY15 do not need to have a retention reason reported, though it will be accepted

# FY15 Retention Window

- ▶ Extended, currently scheduled to close 9/24
- ▶ Review GEN\_ISSUES
  - ▶ FY 15 report explanation now posted
- ▶ Focus on FY14 3<sup>rd</sup> grade students
- ▶ Will be added to Report Card at some point
  - ▶ How many third graders met the Third Grade Reading Guarantee requirements for promotion to 4th grade? *Coming Soon*

# Retention and TGRG

- ▶ For TGRG, a cut score of 392 is used in determining retained status
- ▶ 3rd grade students not scoring a 392 or higher on the OAA must be retained as 3rd graders at the beginning of FY15 unless they met one of the exceptions
- ▶ A retained status option of A-L must be reported for all students who did not score 392 or higher

# New Options for TGRG

- ▶ (A) Student was retained at the end of the previous school year due to the Third Grade Reading Guarantee and is still retained.
- ▶ (B) Student was retained at the end of the previous school year due to the Third Grade Reading Guarantee, but has advanced having demonstrated proficiency as part of ODE's Third Grade Reading Guarantee summer promotion policy.
- ▶ (D) Student did not meet the reading requirement in the Third Grade Reading Guarantee, but was not retained because student met the ELL exemption.
- ▶ (E) Student did not meet the reading requirement in the Third Grade Reading Guarantee, but was not retained because student met the IEP exemption.
- ▶ (F) Student did not meet the reading requirement in the Third Grade Reading Guarantee, but was exempt from retention because student received intensive reading remediation for two years and was previously retained in any K-3 grade(s).

# New Options for TGRG, cont.

- ▶ (G) Student with significant cognitive disabilities is exempt from the Third Grade Reading Guarantee and not retained.
- ▶ (H) Student retained at the end of the previous school year due to the Third Grade Reading Guarantee is not enrolled this school year.
- ▶ (J) Student did not meet the reading requirement in the Third Grade Reading Guarantee, but was not retained due to adequate performance on the Alternative Assessment – Iowa.
- ▶ (K) Student did not meet the reading requirement in the Third Grade Reading Guarantee, but was not retained due to adequate performance on the Alternative Assessment – NWEA-Map.
- ▶ (L) Student did not meet the reading requirement in the Third Grade Reading Guarantee, but was not retained due to adequate performance on the Alternative Assessment – Terra Nova.

# Reporting 3/4 Courses

- ▶ Students retained in 3rd grade due to TGRG who are taking 4th grade courses for subjects other than ELA and reading
- ▶ New subject codes added for ELA and Reading
- ▶ In districts with mid-year promotion policies, these course codes allow for a more seamless transition from 3rd to 4th grade as students master the 3rd grade content



# Reading 3-4 and ELA 3-4

- ▶ 050103 Reading 3-4. This course should contain a majority of 4th graders, but will also include 3rd graders who have been retained due to TGRG
- ▶ 050153 Integrated English Language Arts 3-4. This course should contain a majority of 4th graders, but will also include 3rd graders who have been retained due to TGRG

# 3/4 Courses and Licensure

- ▶ Districts need to make sure teachers meet licensure requirements
- ▶ Licensure requirements have not changed
- ▶ Teacher must be properly certificated to teach students at the appropriate grade level
- ▶ 3rd grade students in courses with 4th grade content will not cause a problem as long as the teacher is properly certified

# FY13N Supplemental

- ▶ Will reopen on Monday, September 29 and close on Friday, October 10
- ▶ All FN records must be submitted
  - This data is replacing what was previously reported
  - Reporting a subset of FN records will create big problems for your district

  - ▶ This data is replacing what was previously reported on these elements
  - ▶ Reporting a subset of FN or GQ records will create big problems for your district

# Verify Your Data, cont.

# Verify Your Data, cont.

- ▶ Verify GQ program codes have been reported for all students who were placed on a RIMP (Reading Improvement and Monitoring Plan)
  - ▶ 152500-152699 regular school year RIMP
  - ▶ 151500 Summer RIMP
- ▶ A RIMP is required for all students found to be not on track based on the TGRG reading diagnostic
  - ▶ Students who were found to be on track may also be placed on a RIMP

# Once Data is Verified

- ▶ Transfer FN and GQ records for FY14N to the data collector
- ▶ Collect, prepare, and preview reports in the FY14N Supplemental collection request
- ▶ Submit your FY14N Supplemental collection request to ODE via the data collector

# FY15 UPDATES

# Recent Changes

- ▶ Students with significant cognitive disabilities are exempt from all TGRG diagnostics
  - ▶ Not just Reading
- ▶ Eliminate Date Type Element option FIEP
  - ▶ FIEP events will now be collected as just another RIEP

# New SE Event Type

- ▶ Special Education Services being provided without an IEP in place
- ▶ Report the following elements
  - Date—date on which the event occurred
  - Date Type—NIEP
  - IEP Test Type—N/A
  - Non Compliance ID—TBD, expired or not reported or not yet adopted
  - Outcome Begin Date—date services began
  - Outcome End Date—not reported unless services are terminated
  - Outcome ID (select from those currently provided)
  - Secondary Planning Element (\*\*\*\*)—N/A



# Community School Early Entrance Policy

- ▶ Reported by community schools only when the LEA has adopted an ODE-approved Early Entrance Student Acceleration Policy for Advanced Learners
- ▶ New DN Attribute
  - ▶ C\_STUEEPOL
- ▶ Valid Options
  - ▶ Y = Yes
  - ▶ N = No

# New KRA Covers Six Areas

- ▶ Language and literacy
- ▶ Mathematics
- ▶ Science
- ▶ Social studies
- ▶ Physical well-being and motor development
- ▶ Social foundations (social and emotional development)

# The KRA System

- ▶ Results go into system
- ▶ System will have an export of results
- ▶ EMIS will work with vendors to be able to import results just as with other vendor-scored assessments
- ▶ Full score information (scaled score) not available at this time- reporting window will be extended as long as needed to get this information

# KRA Scores

- ▶ Raw scores can be used for TGRG Reading Diagnostic if given by September 30
- ▶ Students required to take the KRA who did not complete the assessment must be reported with a reason not assessed option

# Preschool Assessment

- ▶ myIGDI – Individual Growth and Development Indicators
- ▶ To replace Get it, Got it, Go!
- ▶ To be reported in spring of 2015
- ▶ Export results as with KRA

# Staff

- ▶ Report all supplemental employees when hired in both Staff/Course reporting windows
  - ▶ Include individuals whose only position in the district is supplemental
- ▶ HQT and Cert determination
  - ▶ Based on first staff/course collection only
  - ▶ Exact cert and HQT calculation still TBD



# EMIS Manual Section 4.7

- ▶ 3/4 ELA and reading courses added
- ▶ Course name corrected for 110500
- ▶ Marked a number of subject codes for deletion before the start of FY17 (mainly CT courses)
- ▶ Changed the name of several subject codes (mainly CT courses)
- ▶ Added courses in several different Career Fields
- ▶ Career Fields 03, 07, and 15 were combined into one table for Business Administration courses

# Federal Child Count – October 31

- ▶ Formerly called December Child Count
- ▶ Count submitted to federal government based on valid IEPs as of October 31
- ▶ Districts will submit GE records in both Community/STEM School Student Collections and all three Traditional District Student Collections

# Level 1 Validations

Data Collector updated with a new look for the level 1 validation reports

- Hyperlinks to error reports
- Errors are selectable by record type and error severity
- Error message no longer grouped in a single text field
- Data broken out into tables and columns
- No limit on number of message rows (additional errors not suppressed)

Once a district has completed the “prepare” process in the Data Collector, a link to the Level 1 Validation Report will appear if there are any errors





# Level 2 Validation Changes

- ▶ Interface very similar to level 1 changes already shown
- ▶ Data in tables rather than in one text field

# Level 2 Process Changes

- ▶ New schedules for processing
  - ▶ Not always every day
  - ▶ Not always overnight
- ▶ Delivered as results are updated
  - ▶ Data sent to ITCs as data updated at ODE
  - ▶ Will indicate which submission is included in error results
  - ▶ Submission included could vary between different level 2 results



# Level 2 Process Changes

- ▶ Replacing many post-processing reports
  - ▶ By end of year, expect all .csv reports to move to SDC or level 2 results in Data Collector
  - ▶ .TXT reports will continue in zip file to the ITCs for some time to come
