SCR CONFLICTS

General Rules

- ▶ *All* reporting entities submit to SCR
- ▶ Checks are performed on all active records in latest submission where
 - ▶ Received From IRN is not equal to the Reporting IRN or is '999999'
 - ▶ Sent to IRN is not equal to the Reporting IRN or is '999999'
- ▶ Checks ignore records when Withdrawal Reason is '81'

SCR Overlapping Enrollment Check (EPCT)

- ▶ Most important check; released first to make sure system is working correctly and to allow districts to focus on funding impact
- ▶ Districts will have at least until end of August to resolve conflicts, possibly longer
- ▶ Additional checks will be released in coming weeks

EPCT, cont.

- ▶ SSID reported with more than 100% of time
 - ▶ Records with overlapping dates within the school calendar
 - ▶ Based on the latest calendar start date and earliest end date for each district
- ▶ No conflict for overlaps where percent does *not* exceed 100 for certain How Received codes
 - ▶ Assumes overlap acceptable as long as percent does not exceed 100
 - ▶ Example – JVS satellite student
- ▶ Excludes How Received 'E', 'F', 'G', 'N'

EPCT, cont.


Use Student Detail conflict grid to

- ▶ Identify enrollment issues more easily
- ▶ Be proactive in resolving errors ahead of Level 2 validations

Resolving Conflicts

- ▶ Conflicts are resolved when corrected data is submitted to SCR
- ▶ Resolved conflicts
 - Changed to include strikethrough of data
 - Identified conflicts will not entirely disappear; will move to Resolved column on landing page

SCR Refresh Process

- ▶ Districts submit new data
- ▶ SSDT processes submissions daily in the early evening
- ▶ Checks revalidated to see if any new conflicts exist or if any prior conflicts were resolved
- ▶ Districts will see updates the next day

Future Checks

- ▶ Sent to IRN conflict
- ▶ Received from IRN conflict
- ▶ Withdrawn to IRN conflict
- ▶ Admitted from IRN conflict
- ▶ Overlapping enrollment
- ▶ Missing enrollment

Reminder

- ▶ If another district reports a student as enrolled before your withdrawal date, unless attending at your district during overlap, SCR information may be used as supporting documentation to change your withdrawal date
- ▶ Up until now, SCR History has been used
- ▶ Maintain documentation

FTE DETAIL REPORT

About the Report

- ▶ The FTE Detail report includes only the students who generate funding for your district
- ▶ Students reported with a Withdrawal Reason of 81 are not included
- ▶ Students who are included
 - ▶ District Relationship of 1
 - ▶ Sent to Reason of CE

About the Report, cont.

- ▶ Each student will have at least one row of data
 - ▶ Based on Effective Start and End dates on calculated FS/FD range
- ▶ Uses most recent data submitted to ODE

Example of FTE Detail Report

- ▶ This example is for a traditional district
- ▶ The community school report also has a column for adjusted FTE

Calendar Determination

- ▶ Each row of data on the FTE Detail report will be assigned a calendar
 - Some students may have more than one row due to multiple FS or FD records
- ▶ To determine the calendar, we look at the following elements
 - Attendance Pattern
 - Grade Level
 - Building IRN
 - District IRN

Calendar Determination, cont.

- ▶ First, we look for an exact match at the reporting district
- ▶ If no match is found, Attendance Pattern is dropped
- ▶ If no match is found, Grade Level is dropped
- ▶ If no match is found, Building IRN is dropped
- ▶ If no match is found, the state default calendar is assigned (9999999-9999999-**-**)

Calendar Determination, cont.

If the reporting district is a JVSD or ESC

- First, we look to see if there is an exact match reported by the JVSD or ESC
- If no match is found, then we look for an exact match at a unique location IRN
 - Location IRN is taken from the Course Master
- If no match is found, then we drop Attendance Pattern, then Grade Level, then Building IRN, then default to state calendar

Calculating Base FTE

- ▶ Base FTE is calculated from the reported data; it does not include adjustments
- ▶ A base FTE is calculated for each row on the report
 - ▶ Students with multiple rows have multiple FTEs
 - ▶ Total FTE across all rows for a student should not be greater than 1.000000
- ▶ Students with Sent to Reason of CE will have their percent of time set to 100 for the calculation

Calculating Base FTE, cont.

- ▶ Grades KG – 23

$$\frac{\text{ENROLLED HOURS X PERCENT OF TIME}}{\text{CALENDAR HOURS}}$$

- ▶ Preschool

$$\frac{\text{ENROLLED HOURS}}{\text{CALENDAR HOURS}}$$

FTE Fund Pattern Codes

- ▶ An FTE Fund Pattern Code is assigned to each row of the FTE Detail Report
- ▶ Each student can be linked to a line item on the payment report through the FTE Fund Pattern Codes, thus allowing the two reports to be reconciled
 - ▶ A crosswalk showing these links will appear as an appendix to the FTE Detail Report Explanation

FTE Fund Pattern Codes, cont.

- ▶ This is a partial list and includes the most commonly assigned codes
- ▶ A complete list will be included in the FTE Detail Report Explanation

FTE Fund Pattern Codes, cont.

- ▶ FTE Fund Pattern Codes are assigned based on both reported and derived data
- ▶ This is a sample; the complete table will be included with the FTE Detail Report Explanation

FTE Fund Pattern Codes, cont.

- ▶ The default FTE Fund Pattern Code is '*****'
- ▶ If the default code is assigned to a row of data on your report, there is an issue
 - ▶ Verify you are reporting the student correctly; focus on the data shown in table on previous slide
 - ▶ If you are reporting correctly, submit a helpdesk ticket to your ITC as a new FTE Fund Pattern Code may be needed

FTE Adjustments

The following adjustments are made to the Base FTE where applicable

- ▶ 105 Hour Rule – students reported by a district with zero attendance and Withdrawal Reason '76'
- ▶ Where the total FTE is greater than 1.00
- ▶ Overlapping dates, valid concurrent enrollment when FTE exceeds 1.00
- ▶ Overlapping dates, invalid concurrent enrollment
- ▶ E-Schools exceeding their cap amount

Future Enhancements

▶ Future Enhancements

- ▶ Subgroup weighted funding
- ▶ Scholarship students
- ▶ Preschool students

▶ There will be four reports

- ▶ FTE Detail Report – includes all students generating FTE
- ▶ FTE Inactive Report – includes students not generating FTE
- ▶ Adjustment Report – includes all adjustments made to a student's FTE
- ▶ Summary Report

HQT Report

Will be made available as a Level 2 report in the Initial Staff/Course (L) collection

First Staff and Course Collection (FY15)

HQT Report, cont.

- ▶ One report incorporating all previous reports
 - ▶ HQT_ALL
 - ▶ HQT_YES
 - ▶ HQT_NO
- ▶ In prior years, the HQT_ALL report only included courses evaluated for HQT
- ▶ This year, the new HQT report includes all courses – evaluated and not evaluated

HQT Report, cont.

Severity Codes and Descriptions

- ▶ Fatal (F) – HQT incorrectly reported as ‘I-not evaluated’; ODE sets HQT Value to ‘N’
- ▶ Critical (C) – HQT reported as ‘N’; confirm that ‘N’ is accurate
- ▶ Warning (W) – HQT reported, but course is not evaluated; ODE sets HQT Value to ‘I’
- ▶ Informational (I) - Course not evaluated for HQT and HQT Value correctly reported as ‘I’

HQT Report, cont.

▶ HQT Value

- ▶ Derived from option reported in HQT element (CU100)
- ▶ Options 1 – 9 meet HQT
- ▶ All other options do not meet or do not need to meet HQT

▶ HQT Flag

- ▶ Y - Teacher is Highly Qualified
- ▶ N - Teacher is Not Highly Qualified

CTE REPORT

Four CTE Reports

▶ CTE-000

‣ CTE FTEs by Student Enrollment

▶ CTE-001

‣ CTE Student Issues

▶ CTE-002

‣ CTE Course Issues

▶ CTE-003

‣ CTE Staff Issues

CTE-000 Report

Shows student's *potential* CTE FTE and *actual* CTE FTE

- ▶ If potential does not equal actual, an error code will be assigned to indicate the type of error
- ▶ If there are no issues, the indicator be '***'
- ▶ If there are issues, the indicator will show exactly which error report contains the issue (e.g., *2*, 12*, 123, etc.)

CTE-000 Report, cont.

- ▶ A funding date range will be on each line of the report
 - ▶ Start date is based on the later of GN course enrollment start date, FS admission date, FS/FD effective start date, or CN course start date
 - ▶ End date is based on the earlier of GN course enrollment end date, FS/FD effective end date, or CN course end date
- ▶ CTE funding is based on the same FTE Fund Pattern codes as used on the FTE Detail report

CTE Error Reports, 001-003

- ▶ Will be rolling in error checks over the next several weeks
 - ▶ Starting with the most common based on last years data
 - ▶ Continue to work on cleaning errors up through the close of Final Staff/Course collection (end of August)
 - ▶ Level 2 reports will update twice a week in the beginning with the plan to eventually update daily

INVALID CERT REPORT

Invalid Cert Report

- ▶ Position Code and Assignment Area do not impact the proper cert flag
- ▶ Credentials missing teaching fields
 - Impacts credentials renewed in first half of 2014
 - Not all credentials require teaching fields
 - Compare previous license to current license in Educator Profile
 - Request assistance via helpdesk

Invalid Cert Report, cont.

- ▶ Two part checks likely will not be working until after the Initial Staff/Course Collection is closed
 - ▶ Will only change things from N to Y, never from Y to N
- ▶ Most common two part check situations asked about in HD
 - ▶ PK SE where the teacher has an Intervention Specialist *and* an Early Childhood
 - ▶ Teachers who have Adolescent to Young Adult Licenses with a Middle Grades Endorsement and are teaching grades below 7

TGRG, K3 MEASURE, AND RETENTION

Third Grade Reading Guarantee

- ▶ Follow EMIS Manual reporting instructions
- ▶ Report diagnostic results for
 - Reading (KG-3), Math (1-2), and Writing (1-3)
 - All students enrolled 30 or more days, including any new students enrolled during the year
 - **Initial** diagnostic results, even if re-assessed throughout the year
- ▶ Students with the most significant cognitive disabilities are exempt from TGRG
 - Report “EX” for diagnostic result

TGRG, cont.

- ▶ Reading Improvement Monitoring Plan (RIMP)
 - ▶ Required for students not on-track in reading
 - ▶ May also be used with on-track students needing additional help with reading
- ▶ RIMP Intervention Program Codes
 - ▶ **Only** reported for students on a Reading Improvement Monitoring Plan

TGRG, cont.

Report Grade Level Next Year (FN080) of “03” for students who don’t meet OAA cut score (394) by end of 14/15 school year unless

- TGRG **Alternative** Assessment promotion score met
- Previous retention in any K-3 grade **AND 2 years** intensive reading remediation documented
- Reading diagnostic score reported as “EX”
 - Alternate Assessment scores not included
- IEP indicates TGRG retention exemption

TGRG, cont.

Retained Status (FN070) is reported at the beginning of the 15/16 school year

- ▶ Retained status options A-L must be reported for all students who did not meet 14/15 Grade 3 OAA cut score 394
- ▶ If student is retained for multiple reasons (including TGRG), report the most appropriate TGRG retention status option

K-3 Literacy Measure

- ▶ Measures whether a school district or building is making progress in improving K-3 literacy
 - ▶ Uses results from K-3 fall reading diagnostics and the Grade 3 Reading OAA
 - ▶ Alternate Assessment scores are not used
- ▶ Calculations rely on “Majority of Attendance” rules

K-3 Literacy Measure, cont.

- ▶ Focuses on students not on-track with the fall reading diagnostic and follows to the next school year diagnostic looking for improvement to on-track status
- ▶ Also identifies students never on a RIMP, or removed from a RIMP, who did not score proficient (400 or greater) on OAA by end of grade 3
 - ▶ Will cause a demotion in improvement percentage
 - ▶ Decreases the overall numerator by one student

K-3 Literacy Measure, cont.

- ▶ A single improvement percentage is assigned as the K-3 literacy grade for each district
- ▶ TGRG retention will also appear on the Local Report Card
 - ▶ How many 3rd graders met Reading Guarantee requirements for promotion to 4th grade
