FTE DETAIL REPORT ENHANCEMENTS

FTE Detail Report - Review

- ▶ This report will include *all* students who generate FTE for a district's payment
 - ▶ Educated by district (currently)
 - ▶ Educated elsewhere (enhancement)
- ▶ Currently for traditional districts, JVSDs, and community schools
 - ▶ ESCs will receive after enhancements
- ▶ This is the report treasurers would use to reconcile funding

FTE Adjustments

- ▶ Traditional Districts will see Adjusted FTE column added to the FTE Detail Report
- ▶ Community Schools current FTE Detail Report includes some adjustments

FTE Adjustment Report

- ▶ Displays FTE equal to the difference between the base FTE and adjusted FTE on Detail Report
- ▶ Provides detail as to cause of adjustment
- ▶ Replacement for prior FTE Adjustment Report and Disability Not Funded Report

 - ▶ Autism

- ▶ Board of Developmental Disabilities (BDD)

New Codes on FTE Detail Report

Will provide more detail for districts on a student-by-student basis to assist with School Finance Payment Report (SFPR) reconciliation

Inclusion Code

Options

- **FULL** – FTE included in funded IRN's ADM
- **PART** – The portion of student's FTE included in funded IRN's ADM
 - Specific proportion determined by Funding Pattern Code
- **NONE** – No funding to district
 - Out of state
 - Tuition
 - Unauthorized

Inclusion Code - Open Enrollment

- ▶ Resident District's report
 - ▶ **FULL** with FTE that educating district reports
- ▶ Educating District's report
 - ▶ **NONE** with FTE based on own data
- ▶ Resident district gets ADM credit, then dollars are transferred to educating district

Inclusion Code - Full Time JVS

- ▶ Sending District's report
 - ▶ **PART** with FTE of 1.0
 - ▶ Sending District gets 20% of FTE (on the report) included in their ADM
- ▶ JVS's report
 - ▶ **FULL** with FTE of 1.0

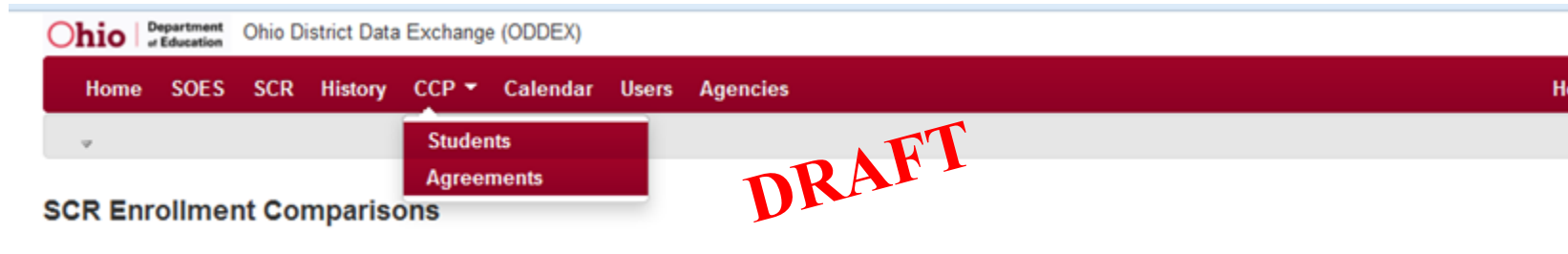
New CCP Module

- ▶ Data population
 - Colleges submit to ODE Higher Ed
 - Districts submit to ODE via Staff/Course 'L' collection
- ▶ Districts approve/reject Courses (Students) and Agreements
- ▶ Records age out at 45 days
 - Auto approved if no action taken by district
 - Resets when updated data submitted by college

CCP - Access Options

- ▶ User's level of access within the CCP module will depend on assigned OEDS role
- ▶ By default, superintendent role gives Flag/Approve access
- ▶ By default, EMIS Coordinator role gives Read Only access
- ▶ New OEDS role(s) (TBD) will be available that give both Read Only and Flag/Approve access

CCP - Navigation Bar Options



- ▶ User can select 'Students' or 'Agreements' to go directly to Summary screen
- ▶ Landing Page will also include a CCP grid similar to SCR and SOES with counts
 - ▶ Approved
 - ▶ Not Approved

CCP – Students Summary, cont.

- ▶ Sorted by ‘Match Percentage’ by default
 - lowest percentage at top
- ▶ ‘Reported By’ FIND option allows user to select records by reporting college
- ▶ ACTIVE ONLY box filters on records with ‘Record Active’ set to **true**
- ▶ Export functionality available
- ▶ Click on SSID or Course Code to open Student Details side-by-side pop up

- ▶ Match Percentage is the number/score assigned to each course based on degree of match on
 - ▶ Subject Code
 - ▶ Location IRN
 - ▶ Converted High School Credit
 - ▶ Semester Code
 - ▶ Attending Building
- ▶ Sent To Percent Of Time not included

CCP - Agreements

- ▶ Module will display an agreement per college per delivery type for district's students enrolled through CCP
 - ▶ If a district has students in CCP at 10 colleges, they will see 10 agreements
- ▶ District must either approve or reject each agreement based on Credit Hour Rate as reported by college

CCP - Agreement Summary

- ▶ Use the Reported By dropdown to list agreements for a particular college
- ▶ Click on college name under HigherEd Agency to open Agreement Approval pop up

FY16 SOES Updates

- ▶ Resident districts will have a new way of communicating data quality issues to community schools
 - ▶ Select “Data Quality Issue” under “Add Review”
 - ▶ Enter comments to provide clarification to the community school
 - ▶ Will not impact funding to the community school
 - ▶ Should be used to address common data quality issues, such as address mismatches

FY16 SOES Updates, cont.

- ▶ Automatic Approval exceptions
 - ▶ Grade Level change due to promotion
 - ▶ Changed enrollment/withdrawal date
 - ▶ 75-day review period still active
- ▶ Funding Impact due to no address
 - ▶ If no address
 - ▶ No flagging ability for resident district
 - ▶ No funding for community school
 - ▶ 75-day review period resets once address added

FY16 SOES Updates, cont.

► Modified flagging options

Status Flags

- Graduated: Resident district believes that a student already has graduated from high school.
- Guardianship challenge: Student is in a guardianship situation & the resident district reported by the community school is not the correct district where the parent resides or resided per Ohio law or in accordance with a court order.
- Homeless challenge: District of residence assigned to a homeless student is challenged.
- Data Quality Issue: Enter comments to provide clarification to the community school. It will not impact funding to the community school and should be used to address common data quality issues such as address mismatches.
- Documented Challenge: Resident district has documentation that a student's address is not within the territory of the district or that the parent is not residing in the district.
- SSID mismatch: SSID reported by the community school differs from the one on file at the district.

Problems Corrected

- ▶ History - Resolved issue with printing from History screen for those using a Chrome browser.
- ▶ History - Corrected rare case where a district may see one additional enrollment record than was necessary

WHERE KIDS COUNT (WKCC)

Where Kids Count (WKC) IRN

Assignment is based on the Majority of Attendance (MOA) IRN and other relevant data reported by the district

- ▶ Typically, MOA IRN used when determining where student will count for % proficient, performance index and attendance rate report card calculations
- ▶ As in past years, specific enrollment and subgroup coding will override the MOA IRN
- ▶ Enrollment and subgroup information will be taken from the March 31 FS and FD records, assuming student was enrolled on that date

WKC Codes

- ▶ WKC code explains WKC IRN assignment and whether the student will count in:
 - ▶ Building, District, State calculations
 - ▶ District, State calculations only
 - ▶ State calculations only
- ▶ Students not enrolled for a Full Academic Year (FAY) are not included in either building or district calculations

WKC Code Definitions

- ▶ WKC IRN is *MOA Building IRN* when
 - ▶ **01** Student is enrolled in one building in district for a Full Academic Year (FAY)
- ▶ WKC IRN is *Accountability IRN* when
 - ▶ **02** Accountability IRN is different from Majority of Attendance IRN
 - ▶ Based on district determination
 - ▶ Both must be building IRNs found within the district hierarchy

WKC Code Definitions, cont.

- ▶ WKC IRN is *MOA District IRN* when
 - ▶ **03** - Student enrolled in a district, but not in one building within the district, for a FAY
- ▶ WKC IRN is *Resident/Sending District IRN* when
 - ▶ **10** - Student educated in another district in a special education cooperative program for a FAY (How Received = B)
 - ▶ Accountability goes back to resident district

WKC Code Definitions, cont.

▶ WKC IRN is *State IRN* when

- ▶ **04** Not enrolled for a Full Academic Year (FAY)
- ▶ **05** Court/parent placed in an institution
 - ▶ How Received = P, T, Q **AND** District Relationship = 1
 - ▶ **OR**, Sent to Code = CT, JV, PS, MR, OS
- ▶ **11** Autism (AU) or Jon Peterson (JP) Scholarship
- ▶ **12** LEP student enrolled in US schools no more than 180 days (FD170 = L)
- ▶ **16** Foreign Exchange student
 - ▶ Grade 10 in US less than 180 days (FD190 not *)
 - ▶ Grade 11 & 12 in US less than 180 days, does not plan to graduate in Ohio (FD190 is N)
